Through several accreditation- and entry forms, Cinekid collects personal details, please find below why Cinekid collects these types of data through the entry forms, and which details we collect. Please note that these personal details will only be used internally and is not shared with other parties, unless clearly stated otherwise in the corresponding form.

Why do we collect information?

- Name
 - To identify you as a user of www.cinekid.filmchief.com, and to keep track of your accreditations and entries.
- Email
 - We collect email addresses to contact you about the selection process of your entry/entries. In case of accreditation, we use the email address also to communicate you about new regarding the upcoming edition of the festival.
- Mobile phone
 - We collect your mobile phone number to contact you in case there are urgent questions about your entry or about your accreditation.
- Phone number during festival
 - We need a phone number to reach you during the festival, in case of emergency and to contact you about urgent questions during the festival.
- Skype name
 - We only collect your Skype name through the Script LAB entry form. We need it so set up Skype interviews which are part of the selection process.
- City
 - We only collect your city of residence through the press and industry accreditation form. We need this for the report for one of our funders.
- Country
 - We only collect your country of residence through the press and industry accreditation form. We need this for the report for one of our funders.
- Nationality
 - We only collect your nationality through the press and industry accreditation form. We need this for the report for one of our funders.
